Thank you for donating to Omeara's crowdfunding page! These terms and conditions apply to your donation, in addition to [Crowfunder's Terms of Use](#) from time to time.

In accordance with Crowfunder's Terms, a contract between us comes into effect on the terms below once the funding period has ended.

1. Merchandise

- 1.1. For any merchandise we anticipate fulfilling your reward item(s) within 30 working days of your donation. Time of delivery shall not be of the essence.
- 1.2. Costs of postage and packaging to mainland UK are included. However, we will contact you to arrange payment for any costs associated with shipping outside mainland UK where applicable.
- 1.3. Exchanges of sized products will be available at our discretion, where stock allows.
- 1.4. Please contact us at info@omearalondon.com if you would like to return or exchange any items. To return an item, you need to let us know within 14 days of receiving it. We will then need to receive the item within a further 14 days before we can process a refund
- 1.5. We promise that our items will be of satisfactory quality and free of all material defects, however all other warranties or implied terms are excluded to the extent permitted by applicable law.

2. Experiences

- 2.1. All experience / events must take place within 1 calendar year of the fundraise closing, unless agreed otherwise in writing.
- 2.2. We will be in touch with those who donate and claim an experience reward within 7 days to discuss the logistics and how to claim your experience.
- 2.3. All events are, of course, subject to us being able to reopen our venues safely (at our discretion) following the Coronavirus pandemic.

- 2.4. **Buy us a pint** - is a donation only, and will not entitle the donor to any reward.
- 2.5. **Virtual Cocktail Masterclass (Zoom)** - no alcohol or supplies will be provided and this will be a consultation based on your own cupboards. Please drink responsibly!
- 2.6. **Dinner & Show** - Omeara will be in touch to confirm details within 7 days of crowdfunder closing; donors will receive two complimentary tickets to a show of their choice (subject to availability and where the tickets are already available for sale on general release) - guests will be requested to present ID on entry to the show. You will also receive 2 meal vouchers which can be used with any of our food vendors (excluding our restaurants) within the Flat Iron Square arches.
- 2.7. **Cocktail Masterclass (in person & private)** - this will take place on a date agreed between us (weekend availability may be limited). The masterclass will include up to 3 cocktails for up to a total of 10 people. Bottomless samples are of course subject to drinking responsibly and reasonably!
- 2.8. **Pair of Omeara Annual Ticket Passes** - this applies to general sale events only and will be subject to reasonable restrictions (please contact us for more information). The pass will be valid for 12 months from venue opening and must only be used by the passholder plus one guest. Passholder will be requested to present ID on entry.
- 2.9. **The Big Party** - The precise scope of the event will be agreed between us. A designated person must be responsible for the event, which will be subject to our Hirer Terms and Conditions.
- 2.10. **Omeara Supper Club** - Details to be agreed between us.

3. Miscellaneous Terms

- 3.1. **Data Protection:** we are committed to protecting your privacy. Your data is collected in accordance with Crowdfunder's [Privacy Policy](#). Any information that we collect from donors in connection with this fundraiser will be used to administer rewards and send further emails about how Omeara is getting on and future events. The Promoter will not pass on the information collected to any third parties except to the extent required to fulfil any rewards. Please contact us if you do not wish to receive further marketing materials from Venue Group.

- 3.2. Venue Group will only use information collected to fulfil rewards and communicate with you as set out above, and will treat all data with the utmost care inline with their own privacy policy: [LINK](#).
